2. That all information regarding business for sale is provided by the Seller or sources and is not verified in any way by Broker. Broker has no knowledge of the accuracy of said information and makes no warranty, express or implied, as to the accuracy of such information. Understanding that, I/we shall make an independent verification of said information prior to entering into an agreement to purchase any business, I/we receive or fail to receive, and I/we agree to indemnify and hold Broker and its agents harmless from any claims or damages which may occur by reason of the inaccuracy or incompleteness of any information provided to me/us with respect to any business I/we might purchase.

3. That should I/we enter into an agreement to purchase a business, I/we will provide a financial statement and a personal and business history, and I/we authorize the Seller to obtain through standard reporting agencies financial and credit information about me/us or companies I/we represent, if is applicable.

4. I/We acknowledge that the Broker will be representing both Buyer and Seller, unless stated otherwise by Broker. The Broker has a contract providing for a fee to be paid to Broker by Seller upon sale, lease or transfer of Seller business or property. You authorize Broker to represent you in negotiating leases and any potential financing of any of the business Broker introduces to you. If you do not wish Broker to represent you in the negotiation of leases or financing, please notify Broker in writing prior to any negotiations taking place.
